Accessory Dwelling Units (ADUs) Come to Sunset Village

ADUs stand for Accessory Dwelling Units, sometimes called “granny flats” or “mother-in-law” apartments. They can be over-the-garage apartments, back yard cottages, basement apartments. Madison’s new zoning code, effective January 2013, allows ADUs as a conditional use in all Residential zoning districts. Conditional use permits are granted by the Madison Plan Commission, which considers the project design and staff recommendations as well as public comments.

Jim and Carole Vincent, 221 S. Midvale Blvd., sent a Letter of Intent (April 2014) to the Plan Commission proposing an ADU at the southeast edge of their lot, “689.5 square feet of living space with 532 square feet of garage (two car) below.” They say, “This project takes advantage of recent changes in the Zoning Code which will allow us to provide a small residence for one or both our children at our home in exchange for maintenance and other duties we require.”

The 221 S. Midvale ADU conditional use proposal came to the Plan Commission on June 9, 2014. Several Sunset Village residents spoke during the Public Hearing part of the meeting. The following are excerpts from their testimony.

Jim Vincent (221 S. Midvale) explained that the ADU would be 2.5 levels, including a ½ level sleeping loft, and is intended for a family member or care-giver. The foundation was already poured for a two car garage in late 2013 when his family saw the Isthmus article introducing the new zoning ordinance that allows ADUs; they then met with Design Coalition and produced a plan.

Andrea Kruk (305 S. Midvale) spoke in opposition, citing overcrowding, invasion of backyard privacy, traffic and parking congestion, and the bad precedent the project would set in a single home neighborhood.

Kevin Vincent (221 S. Midvale) spoke in support, citing the expense of assisted living and advocating ADUs as an alternate type of eldercare and a more progressive solution than adding to urban sprawl.

Jenni Briggs (225 S. Midvale) spoke in opposition, as the immediate neighbor to the south, citing loss of backyard privacy and sanctuary from a busy Midvale (“We treat our back yards as a sanctuary.”); and concerns about height (nearly 25 feet), the wraparound balcony, and light and noise pollution. She said, “If the Vincents want this as an extension of their house, then make it an extension of their home.”

Erik Olson (217 S. Midvale) spoke in support, as the immediate neighbor to the north, approving the design, the density and the intergenerational living arrangement.

Marjorie Hamacher (305 S. Midvale) spoke in opposition, citing loss of privacy, degradation of property values, congestion, inappropriate urban-style crowding, loss of green space.

The Plan Commission also had written comments submitted by Jenni Briggs, Ulrike Dieterle, and Ken Raffa, SVCA president, all in opposition. Ken Raffa wrote, “The main concerns arise from the sheer mass of this proposal. Specifically, it would greatly infringe on the solace of immediate neighbors, sets a bad precedent that could undermine the neighborhood’s vision that was solidified after much hard work in our just-approved neighborhood plan, and would aggravate storm-water runoff problems through the added impermeable surface.”

The Analysis and Conclusion of Plan Commission staff reads as follows:

“Accessory dwelling units are conditional uses in all Residential zoning districts. The Planning Division believes that the proposal can meet the conditional use standards despite some concerns about privacy expressed verbally to staff by the neighboring property on the south and a written comment received questioning the appropriateness of ADUs in the Sunset Village neighborhood. Staff feels that the proposed accessory building complements the existing 1,696 square-foot principal single-family residence well, in particular the emphasis on matching the architectural style of the principal and accessory buildings and their building materials. The garage appears to meet all general requirements for accessory buildings, and the ADU generally conforms to the relevant supplemental design requirements and guidelines in MGO Section 28.151.”

The motion to grant the conditional use permit passed the Plan Commission unanimously, with amendments to require translucent south facing windows and with some pavement changes. The project is scheduled to be completed by October 2014 and will have a new address, 223 S. Midvale.

A second Sunset Village ADU is in the works. Bert Dennis, 220 N. Meadow Lane, has applied for a conditional permit for a detached garage with apartment above. There will be a public hearing at the August 11 Plan Commission meeting.

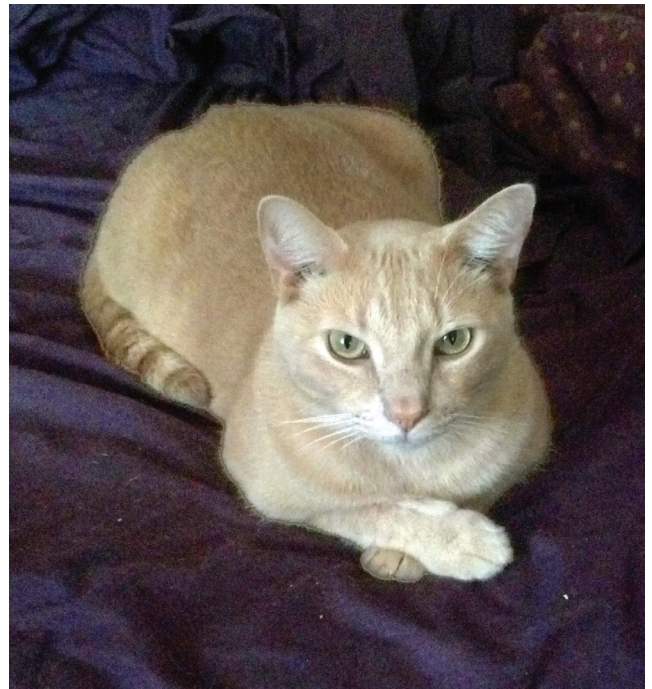

Rocky Bluff Cat Found in Sunset Village!

I posted on the community list a few months ago when my cat, Spot, went missing. More than two weeks later, I posted a notice of his safe return. I've been asked to write up a little account for the community newsletter, so here is Spot's story. Spot... is a strong and determined cat who, for some unknown reason, enjoys being out in the rain. At the end of June when we had that series of thunderstorms coming through, he managed to open the patio door and slip out in the middle of the night, in the middle of a storm. In the morning, when I found the semi-open door, I was concerned but not too worried. I called him and walked up and down the street a few times, with no success. After his second night out I began to really worry. After his third, I made up posters. I passed them out to everyone on our block and put them up on telephone and light poles on every street within about a mile of the house. They went up on bulletin boards at grocery stores and the library and I filed a report with the Humane Society and visited every few days to check the found cats.

I was nearly despairing of ever finding Spot when the phone rang early one morning. The young man on the phone, a Chinese graduate student, had heard a cat under his porch for several days and finally managed to get a glimpse of it. He'd seen my poster on a pole across the street. I grabbed my flashlight, and headed over to his house, which turned out to be about two blocks [corner of Owen and Regent] away as the crow flies (or the cat strays). When he showed me where the sound of meowing was coming from, I could hardly believe it. The porch was more like a very low deck, with a gap under the front of only a few inches. I had to lie on the ground with my eyes right up against the opening to be able to see into the space under the deck. Sure enough, there was a cat howling under there and after a lot of calling he emerged where I could see him. He was scruffy and thin, and his collar was missing, but he looked like my boy. I eventually had to pry up two of the paving stones in front of the porch to create enough room for him to squeeze through. I still have no idea how he got under that porch or even how long he'd been there, but I'm very grateful to the young man who called the number on my poster and gave this story a happy ending.

Anne Fuller is one of numerous Sunset Villagers who grow milkweed for monarch butterflies, in separate patches or incorporated into informal perennial plantings. Female monarchs lay their eggs on the undersides of milkweed leaves so the caterpillars can feed on them, and adults feed on the nectar of the flowers, as seen in the photo Anne took of her Heather Crest terrace milkweed. If you bend down to examine the pink flower clusters, you will smell the sweet scent of summer.

New Shorewood Bike Path Segment

This paved multi-use (bicycle / pedestrian) path will extend the existing Blackhawk Path on the northwest side of Madison (and Village of Shorewood), creating a route to Middleton and, ultimately, other communities west. It generally follows the corridor of the former Soo Line railroad. The existing Blackhawk path provides a direct route to the University, two major hospitals, retail areas and other important commercial and employment destinations, generally paralleling one of the most heavily traveled streets in the City. Westward it links a number of communities including Middleton, Cross Plains, Mazomanie and Black Earth.

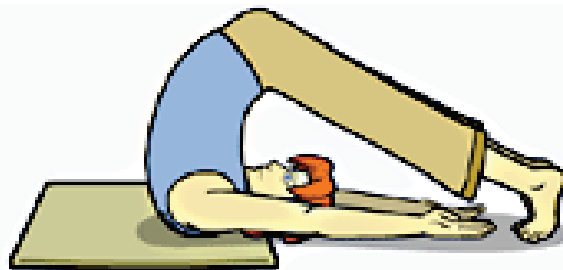

John Ottinger, former newsletter editor, dies

John was the Sunset Village Voice editor from November 2004 until August 2007. He died on July 1, a few days short of his 77th birthday. He and his wife, Peggy Lison, moved to South Blackhawk Avenue in 1988 and created a truly magical garden for all manner of blooming, flying and four-footed creatures. John was always proud to relate that the first residents of his home were violinists Rudolph and Lorna Kolisch. He wrote, in a 2007 SVCA newsletter, "Despite its small size—less than 900 square feet—and lack of amenities (as far as we know there has never been a garage) world famous musicians like Paul Badura-Skoda and Gunnar Johansen congregated in the home for rehearsals and other musical gatherings. Kolisch was a perfectionist and preferred that everyone play from memory. Kolisch was also one of the very few professional violinists who played left-handed, due to a childhood hand injury. This required that his violins be restrung to accommodate him, but he played brilliantly nonetheless." Thanks for your stories and music, John.

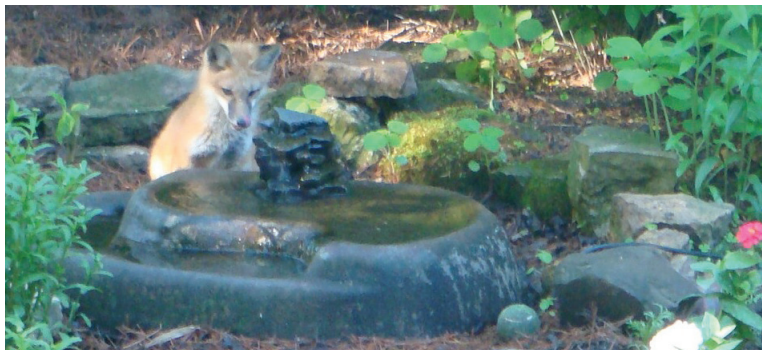

Fruit & Nut Tree Planting Plan for Lucia Crest Park

The city of Madison approved the planting of up to 14 dwarf fruit and nut trees in the far northwest corner of Lucia Crest Park; info and a map can be viewed on the SVCA website <http://sunsetvillagecommunity.org/> and Facebook page. In addition, the city has awarded a grant of \$2,000 to help cover the cost of the trees, landscaping, signs, and additional items.

History of the project: In 2012, two old apple trees were removed from the far west side of Lucia Crest Park. At the December 2013 SVCA quarterly meeting the board supported the idea of planting additional trees in the park and recommended gathering additional input from neighbors. The winter 2014 SVCA newsletter contained the initial proposal for the fruit tree plantings. Feedback from 10 neighbors was positive and proposed planting more trees and a greater variety of trees, yet maintaining open space in the park for recreational activities. There were no negative comments. An update in the spring 2014 newsletter described the grant approval process.

An interested group of neighbors (Liz and Ben Ringle, Jamie MacAlister, Dan Lindner, Kate Kemper, and Brian Andersen) has worked with the city to develop the plan, which includes trees from a city approved list. The trees were selected for their winter hardiness, disease resistance, and low maintenance properties. No harmful pesticides or herbicides will be used.

The plan will be to clean up the area in the summer and fall of 2014 with the planting of trees in the fall of 2014. If you have comments or would like to volunteer with the cleanup and planting please call Brian Andersen at 608.228.2414 or e-mail at banderse@yahoo.com.

Accidental Bowel Leakage

Accidental Bowel Leakage (ABL) affects tens of millions of older Americans and is the accidental loss of liquid or solid stool from the rectum. Common conditions associated with ABL include irritable bowel syndrome, constipation or loose stools, urinary leakage, older age, childbirth, prostate treatment, diabetes, and obesity.

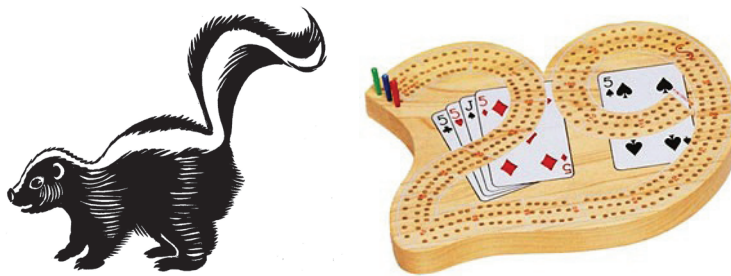
