SVCA neighborhood meeting: Thursday, March 19th at 6:30pm Sequoya Library 4340 Tokay Blvd

Greetings Neighbors:

First, our sincere thanks to our Madison Police officers for their rapid and thorough response to the early-November shooting on Hillcrest Ave. Thanks also to Police Chief Michael Koval and West District Captain Victor Wahl for coming to our December SVCA meeting and answering everyone's questions. Likewise, thanks to Mayor Paul Soglin for attending our meeting, and for offering to work with the City Attorney on a plan to notify neighbors about foreclosures so that neighbors can report unauthorized residence.

At our last meeting City of Madison Zoning Administrator Matt Tucker and Alder Chris Schmidt listened to neighbors' concerns about Accessory Dwelling Units. They explained the city's policy, and recognized there is need for improvement. They said they would work with SVCA to try to help city policy become more sensitive to local neighborhood values.

Our upcoming meeting will include another presentation that should be informative and helpful to many neighbors. Eric Dundee from the Madison Engineering Division will give a presentation on the sidewalk and gutters project planned between Hillcrest Ave. and Mineral Point Rd. This is a good opportunity to ask questions, raise concerns, voice support, learn the specifics, etc.

Our next meeting will be Thursday, March 19 at Sequoya Library from 6:30-9:00.



SVCA December Quarterly Meeting Draws a Crowd

The December 1 SVCA quarterly meeting was unusually well attended because of the two major agenda items, the November 10 Hillcrest shooting incident; and the impact of the Accessory Dwelling Unit at 221 S. Midvale Blvd. Twenty-three Sunset Villagers were joined by guests: Mayor Paul R. Soglin; Chief of Police-Michael C. Koval; West District Captain of Police-Victor Wahl; Dane County District Attorney-Ismael R. Ozanne; District 11 Alder-Chris Schmidt; City of Madison Zoning Administrator-Matt Tucker

Agenda item #1—Shooting incident at Hillcrest

Captain Wahl provided a factual summary of the shooting incident at 3922 Hillcrest:

- November 10, 2014 police received reports of shots being fired
- Police found shell casings at the scene, no victims at scene
- Officers were directed to UW Hospital Emergency Room where a person was admitted with a gunshot wound. Police interviewed the person and determined that the shooting victim at the ER was the result of the shooting incident at Hillcrest; the victim cooperated.
- Officers recovered handguns from a vehicle on Hammersley Rd.
- By 5:00 p.m. that afternoon the police had two suspects in custody.
- Currently, there are no additional people sought by the police department.

According to Captain Wahl, the residence had two previous police calls this year and is currently in foreclosure. The

foreclosure on the home started earlier this year, according to the Mayor. Because the home was in foreclosure, the lending institution had to request that the squatters vacate the premises and have the Dane County Sheriff's office secure the premises. Although the city couldn't evict the squatters, Captain Wahl and Chief Koval reported that the Madison Police Department assisted the Dane County Sheriff's office during the eviction today (Dec. 1). The current squatters were evicted and the house was secured.




Agenda item #2— Zoning code discussion regarding the 221 S. Midvale Blvd. accessory dwelling unit (ADU)

Matt Tucker reviewed the recent history of the zoning code. Jenni Briggs brought a photo poster of the ADU at 221 S. Midvale Blvd., taken from her next door lot. She said that she is very unhappy about the ADU under construction, that it is adversely impacting the enjoyment of her property, and asked if the ADU could be stopped by the city. Matt Tucker indicated that the ADU currently under construction will not be stopped by the city.

The discussion turned to reviewing the process for amending the Neighborhood Plan and/or the zoning ordinance, and the process to register neighborhood input. Those interested in getting involved in this discussion should organize into a sub-committee to develop specific feedback about the ADU. Matt and city staff would be happy to help with technical language and terminology. Ald. Chris Schmidt indicated that he would discuss the best process with city staff.

Chief Koval on the Hillcrest Shooting

November 24, 2014, letter from Madison Police Chief Michael Koval

TO: Alders and Neighborhood Constituents

SUBJECT: Hillcrest and Alden Shooting

Thanks for the willingness to share concerns and ask questions about the quality of life issues affecting this neighborhood. It is always gratifying to hear stakeholders provide feedback . . .a true measure of your investment in Sunset Village and keeping it great!

At the outset, what occurred in the neighborhood should be viewed as an anomaly; the result of a "perfect storm" wherein a home that is going through a foreclosure process (a slow and arduous legal process that is largely the purview of the County) became a sort of



makeshift sanctuary for some squatters. The address in question—3922 Hillcrest—had only been the subject of two previous (unremarkable) calls prior to the day of the shooting. Thus, it had not been identified as a major issue in this relatively quiet part of our City. Given this context and in light of varying accounts that are circulating, I hope the following information provides some clarity.

Officers initially responded to a report of shots being fired in the area of Hillcrest & Alden. Officers did not locate any victims at the time, but did locate shell casings in the street. About 45 minutes later, officers were dispatched to a local emergency room regarding an individual who had come into the ER with a gunshot wound. Officers quickly determined that this person was connected to the call at Hillcrest/Alden, and additional resources were dedicated to the investigation.

That afternoon, MPD officers observed the suspect vehicle leaving an address in the Hammersley Road area. The vehicle was stopped and several individuals were detained. Two firearms were recovered from the vehicle. Two suspects were initially arrested on unrelated charges, but have since been charged with multiple offenses related to the shooting (including

one of them charged with attempted 1st degree intentional homicide). So, the suspects involved in this shooting were in custody within a few hours of the incident.

The foreclosure process has nearly come to an end, and the court has issued a "writ of assistance," which allows the Sheriff's Office to post the property and then forcibly remove anyone remaining (and secure the building). The building has been posted and I anticipate that the actual forcible eviction will be coming soon. Note that the eviction process and function lies with the Sheriff's Office as a matter of statute, and MPD has no direct involvement with it. That said, I am confident that we will be reporting progress on this front and this will provide us all with a greater peace of mind!

Captain Victor Wahl (West Police District) has taken the liberty of scheduling himself to appear at the next SVCA meeting on 12/1/14 at 6:30 p.m. at the Sequoya Branch Library. Please feel free to contact Captain Wahl directly with any additional questions or concerns you may have relative to this topic or others as the Sunset Village Neighborhood is under the West Police District's area of coverage.

In closing, while I have no doubt but that this has been a very uncomfortable series of events, Sunset Village is one of our safest neighborhoods in the City and with your help as partners, we can keep it that way! Respectfully, Michael C. Koval, Chief of Police

208 W. Sunset Court Demolition and Rebuild

comments to SVCA listserv by Chris Pitzner, Dec. 15, 2014

I wanted to provide the list with a bit of an update on the demolition and "remodel" of 208 West Sunset Court. A public hearing related to the demolition permit submitted to the City of Madison Department of Planning & Community & Economic Development was held this evening.

First of all, a shout-out to Todd Courtenay and Mary Mahon who registered to speak on behalf of the neighborhood, and voiced neighbor concerns eloquently, calmly and logically. Thank you for coming out to speak, and thank you to my entire neighborhood who has been proactive about making sure this process follows the law and respects the process.

My understanding of the public meeting follows. The "demo" permit was approved this evening, so I would expect construction will resume again soon. As both Todd and Mary pointed out, that was largely a foregone conclusion as the demo has already occurred. As one of the Alders pointed out, since the lot is now empty, the temptation would be to punish the contractor by further delaying the project, but really, that also punishes the neighbors. Therefore, they voted to pass.

It's also worth noting that a criminal prosecution for demolition without a permit, separate from this process and regardless of the approval this evening, is underway.

The revised plans are more in keeping with the Neighborhood Plan and the concerns submitted by neighbors; I don't believe these revised plans are yet fully approved, and the commission stated that will occur inspections throughout the construction process to insure that the construction matches the plans. Both Todd and Mary stated concerns related to the fact that the contractor (Two Dogs Construction) has not acted in good faith up to this point and the concern is that construction will continue to differ from whatever permits



are obtained. (This is also my top concern.) I certainly hope...that from here on out things improve. I'm excited to have a back-door neighbor again, and ideally [one] who is invested in that property and the neighborhood.




Winter Gear Needed

Car-Sharing Public Meeting

The City of Madison Parking Utility will be holding a public meeting to explore the potential for expanding car-sharing in Madison. Representatives from car-sharing companies will make short presentations, with a question and answer session to follow. Car-sharing has been known to reduce the need for car ownership. According to a nationwide study published by the University

of California Transportation Center, one car-sharing vehicle can replace as many as nine to thirteen individually owned vehicles, resulting in reduced congestion, greenhouse gas emissions, and need for parking supply.

Shared Values, Creative Partnerships Shaped 2015 Budget


When crafting Dane County's 2015 budget in challenging economic times and when facing economic uncertainties, I am pleased that in Dane County we kept costs down for taxpayers through collaboration, while protecting important services, quality of life and our communities' most vulnerable citizens. Working together with our County Board, excellent staff, service agencies and private partners, we collaborated to protect core services - from public safety to the safety net - and strengthen the quality of life that attracts people and economic development to our county.

The budget also builds up Dane County's rainy day fund (to a projected \$20 million), that was in negative numbers after the recession when I took office. This is important because state government is facing a \$2 billion-plus deficit, and in the past they have balanced their budget with cuts to local communities and services.

A few budget highlights include:

- 46 miles of additional roads being plowed 24-hours-a-day and seven new compressed natural gas snowplows that help combat climate change and save taxpayers' money
- Unprecedented \$10 million in efforts to clean up Dane County lakes and waters, realized through new partnerships
- Development of new bike paths and recreational spaces, including the Lower Yahara Trail and a new matching grant bike trail program
- A focus on investments to get families out of homeless shelters and into affordable housing, as well as building on job training and employment services for youth
- Pilot environmental projects to protect Dane County's environment, including solar at the medical examiner's new building and CO2 elimination system at the landfill.

Our top goal was to protect the quality of life that our community values and that also keeps our economic development and job creation far outpacing the rest of the state. I am grateful to the many partners who worked with me to meet these goals.

We encourage you to apply for activities and projects that either build capacity and/or beautify public places. There is a total of \$30,000 grant dollars available for awards in 2015. Additional information on the grant program is on the City's webpage: www.cityofmadison.com/neighborhoods/grantprogram.htm. All applications will be evaluated through a competitive process and grants will be awarded by the City Council. Application deadline is March 2, 2015 by 4:30 pm.

Neighborhood associations or neighborhood planning councils officially recognized by the City of Madison; and business associations consisting of at least four block faces are eligible to apply. Projects/activities should ensure that business district and neighborhood associations work together to make neighborhood business districts strong, healthy, and integral parts of their neighborhoods.

Two types of projects/activities are eligible: ones that improve the organizational capacity of neighborhood associations in addressing issues, improving conditions, and enhancing the quality of life within the neighborhood or ones that improve the appearance and livability of the neighborhood's public spaces, preferably highly visible spaces such as streetscapes, gateways, and neighborhood business areas.
