Wisconsin Humanities Gives Grants to Cultural Organizations

This past summer, your local non-profit, the Wisconsin Humanities on Regent Street near Hoyt Park, provided emergency funding to other non-profit cultural organizations facing financial hardship resulting from the impact of COVID-19. These grants were funded by the federal CARES Act via the National Endowment for the Humanities. From villages as small as Cobb in Iowa County with a population of 458 to cities as large as Milwaukee, \$548,000 total was given to folklore, arts and nature centers, and libraries, museums, historical societies, and literacy councils. Grants ranged from around \$700 to \$7,500 apiece. The funds were to help keep staff on salary, pay the rent, and weather the months of closure.

Over 80 different agencies benefited from these grants. Madison Reading Project, an agency on the far west side that distributes books to children in Dane County, was among them. In the last six months, MRP has provided over 30,000 books to children, and with Wisconsin Humanities' help, they are continuing to provide them during the new school year this fall.

The Wisconsin Humanities is a resource for cultural organizations statewide that provide public programming to strengthen community life. *Might there be an organization in the Sunset Village neighborhood that would like to explore receiving funding for a public program?*

Polling Location Change: Ward 82

Due to COVID-19, Ward 82's polling location has moved from the Midtown Police Station to Bethany United Methodist Church, 3910 Mineral Point Rd. Why did our polling place change again? Election workers discovered that the Midtown Police Station was not big enough to accommodate the 6 feet of social distancing required for safety during the Coronavirus pandemic. We want to make sure that voting is as safe as possible for voters and Election Day staff. Poll workers also had a difficult time with deliveries of supplies (like more ballots) due to the fact that the front desk staff often has to frequently be away from the desk for their daily work.

New Leaf and Yard Waste Collection Schedule Begins October 11

The Streets Division will be using a brand-new leaf collection schedule for the fall of 2020. All Madison neighborhoods have assigned days to set leaves and yard waste out for curbside collection, beginning October 11, 2020.

The leaves and yard waste collection schedule is now available at www.cityofmadison.com/yardwaste. Enter your address into the form provided, and you will see **three dates** to set out leaves and yard waste. Each of the dates listed on the website is a Sunday. Collection crews will be working through the scheduled neighborhoods the week following the date listed on the website. Residents without internet access can contact the Streets Division office that services their home to receive the set-out dates for their home (608 266-4681 for Sunset Village).

Why was the leaf collection system changed?

Due to the budget hole caused by the pandemic, the Streets Division was unable to hire the usual number of seasonal employees. Fewer employees will mean crews collecting leaves will be smaller. Smaller crews mean collection speed will be slower. And slower collection means fewer opportunities to have leaves picked up at the curb. Crews will also need to be sure to practice social distancing while pulling leaves from the terraces, which is also likely to slow crews down. The new schedule is an effort to deploy personnel strategically and provide residents with the exact date when to set their leaves out for pickup so no one misses their curbside collection opportunities.

All collection rules remain the same. Do not place yard waste into the street. Placing yard waste into the street creates a nutrient-rich runoff that goes into the storm drains that lead to our lakes, causing algae blooms and other problems. When the collection season is underway, you can pile leaves and yard waste loose on the terrace, or place the material into bags. If bagging yard waste, compostable paper leaf bags are preferred. All bags should be kept open at the top so crews can identify what is inside. More information about how to set leaves out for pickup can be found on the Streets Division's website.

Remove Street Leaves Before the Rain

Sunset Village is fortunate to have an abundance of beautiful large trees throughout the neighborhood. These trees provide welcome shade in the summer, but also drop lots of leaves in the street come fall, which can be harmful to our lakes. When it rains, stormwater flows through leaves that collect in the street creating a “leaf tea” rich in dissolved phosphorus. This “leaf tea” washes down neighborhood storm drains, eventually making its way to either Lake Mendota or Lake Wingra.

When stormwater runoff contains too much phosphorus it can lead to toxic algal blooms, low oxygen levels, and green murky waters, none of which are good for animals living in the water or those of us who use it for recreation. The good news is that removing street leaves before a storm can help protect our waters. In the fall, timely removal of street leaf litter can reduce the amount of phosphorus in urban stormwater by 80% compared to no leaf removal!



Join us in keeping streets leaf-free this fall! It's easy! Before the rain...

1. Safely remove leaves from the street in front of your home and nearby storm drains.
2. Pile collected street leaves on terrace next to the street or recycle leaves on your property.

3. Sign up to receive Leaf-free Streets Rain Alerts this fall (Oct. 1- Nov. 30). Alerts will be issued (via text or email) 1-2 days before a significant rain event reminding you that it's time to remove street leaves.

4. Put up a sign in your yard and encourage your neighbors to join you in removing street leaves before the rain. To request a sign contact Christal Campbell: campbell.christal@countyofdane.com or (608) 224-3746.

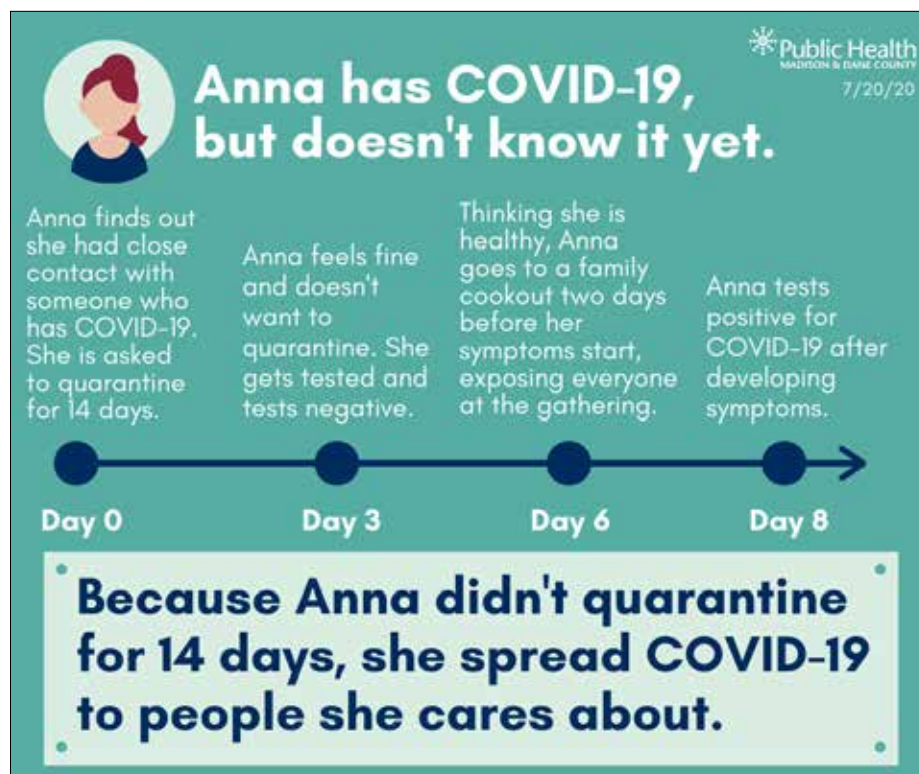
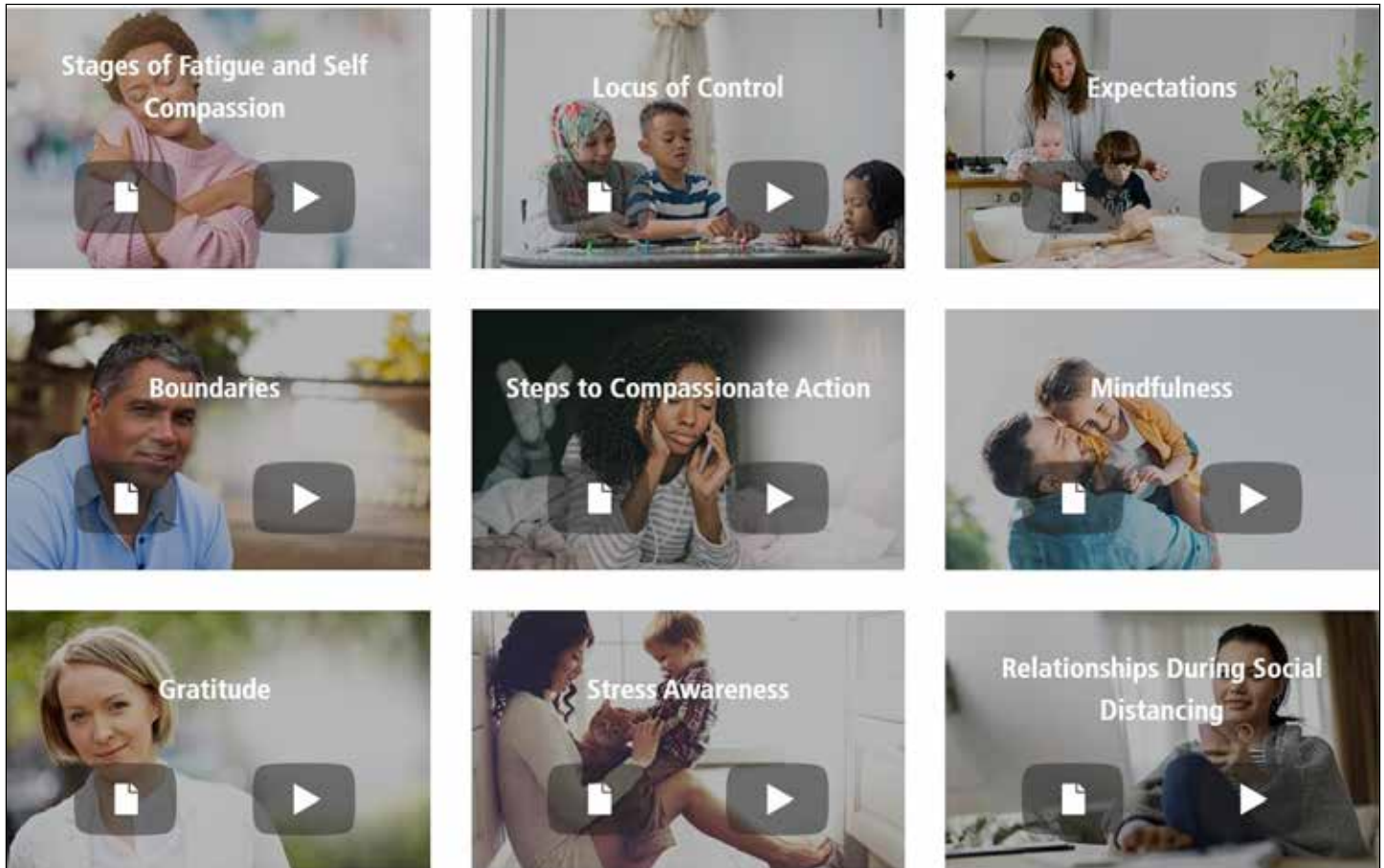
Dog People – Please Control Your Dog

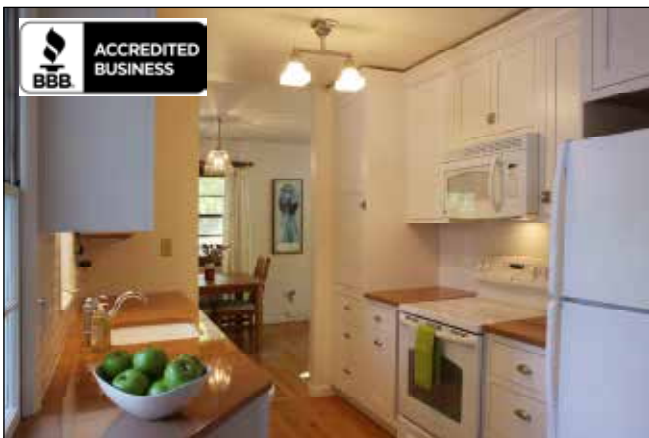

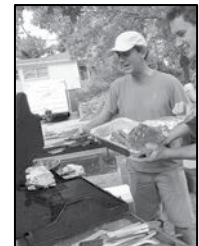

Spooky Sunset Stroll - A Socially Distanced Halloween

Sunset Village neighbors are welcome for a “Spooky Sunset Stroll” in Sunset Court between 5:30-6:30 on Saturday, October 31. This is not a gathering or a parade, but rather an alternative to door-to-door Trick Or Treating during the pandemic. This will take place in a one-hour window so that there is ample time for groups to walk through without crowding and to give residents a clearly designated time during which to participate.

Children from throughout Sunset Village are invited stroll around the Court in their costumes, maintaining distance from other family groups. As they stroll there will be opportunities to collect candy at intervals around the court, and small grab bag prizes will be safely shared at the park entrance by the bridge. Strollers should walk counterclockwise around the court to help avoid merging groups.

Sunset Court residents are invited to be outside in their driveway or front lawn to greet children and to offer candy in a safe way (bowls of candy set out away from group, candy chutes, boo bags, etc.). Neighbors and families are expected to follow Covid protocol and use masks and social distance measures, reminding children to stay within their family group. All families that feel comfortable participating are welcome. It is also understandable if neighbors on the Court would prefer not to participate. We kindly request that no traditional door knocking take place that evening.

Happy Fall SVCA Neighbors!

To say that the last few months have been difficult is an understatement. As we continue to navigate this new normal, at least for the time being, please know that the city is working to come up with innovative solutions to our problems. That said, we are facing issues as a City right now. We've seen an increase in certain crimes that are cause for concern. Please see recent statistics for our district that I am including here:

SHOTS FIRED: In August of 2020 there have been 3 shots fired in MIDTOWN.

BURGLARIES: In MIDTOWN in August of 2020 there were 32 burglaries; in 2017, 16; 2018, 23; 2019, 8.

STOLEN AUTOS: There were four stolen autos in MIDTOWN in August of 2020, compared with two in 2019.

THEFT FROM AUTOS: In MIDTOWN there were 23 theft from autos in August compared to 29 in 2019.

This rise in crime is not unique to us here in Madison. It has been noted across the country. We don't yet know why this rise is happening, though there are many theories ranging from the COVID pandemic to a bad economy. Without understanding the root causes of this crime spike, I have been looking at ways to interrupt this cycle of violence, from immediate, to intermediate and long-range responses.

Diverting City funds directly from MPD doesn't seem to be an appropriate solution to the problems we face. I have worked with MPD, MFD, and Dane County to find a way to divert certain mental health calls away from MPD, where even the most compassionate and trained officer can escalate a crisis by showing up in a police uniform. We are taking a serious look at programs that not only provide better solutions for those who suffer these emergencies, but also do it while saving money for the city and the county. We are giving consideration to models like CAHOOTS in Eugene, Oregon, and the STAR model from Denver, Co.

We continue to look at immediate interventions, like the ones that work to eliminate violent retaliations in response to crimes. And I also continue to work with our Community Development Office to fund programs that will help create long range opportunities for youth who may not have many options otherwise. This isn't a problem that can easily be solved by throwing money at enforcement, but I will continue to look at evidence-based solutions to continue to reduce crime in Madison, and the Midtown District.

Westside Community Conversation about Crime in our Neighborhoods

Madison West District alders hosted a video conference on Thursday, September 24 to address crime in our neighborhoods. Participants included Judge Everett Mitchell, Presiding Judge for the Juvenile Division; District Attorney Ismael Ozanne; Chief Victor Wahl of the MPD; Midtown Captain Jason Freedman; and several Westside alders.

In-Person Absentee Voting is an Option at Sequoya Library

For the November 3, 2020, Presidential Election, we will offer In-Person Absentee Voting October 20 - November 1 (no voter registration on October 31 or November 1, per state law). Our in-person absentee voting sites will primarily be drive-up or outdoors. We need to make sure the ballots do not get wet. On days we have inclement weather, please check the website (see below) or call the Clerk's Office at 608-266-4601 before heading out to vote.

Drive-Up/Walk-Up In-Person Absentee Procedure

1. If you have your own ballpoint pen to use, please wave it at the absentee clerk as they approach you at a drive-up/walk-up absentee voting site. The absentee clerk will be wearing a reflective vest and a face mask.
2. The absentee clerk will give you an absentee envelope to fill out on a clipboard that is disinfected after each use.
3. The absentee clerk will need to check your voter ID. You may hold your ID up to your window.
4. Once you mark your ballot, you will seal it in the absentee envelope.
5. You will sign your envelope in the presence of the absentee clerk. The absentee clerk will sign as your witness.
6. At the end of the drive-up/walk-up voting shift for the day, your absentee will be brought to the Clerk's Office in a courier bag with a tamper-evident seal. The unique serial number on the tamper-evident seal is documented on a chain-of-custody form, as is the number of absentee envelopes sealed in the courier bag.
7. The Clerk's Office will verify the serial number on the tamper-evident seal, and the number of absentee envelopes sealed inside the courier bag.
8. Your absentee will remain sealed in its envelope and secure in the Clerk's Office until it is delivered to your polling place to be processed on Election Day.
9. On Election Day, the poll workers at your polling place will check your envelope into the poll book, and will feed your ballot into the tabulator to be counted.

City of Madison poll workers were in every Madison park, including Lucia Crest Park and Sunset Park, on September 26 and October 3, to register voters and accept delivery of absentee ballots; and, if needed, sign as witness for absentee voters. After the event poll workers secured the absentee envelopes with a tamper-evident seal and documented the seal number and the number of absentee ballots. Poll workers then took ballots straight to the City Clerk's Office, where both the seal number and the number of absentee ballots were verified. The Clerk's Office scanned the barcode on each returned absentee envelope, so voters were able to check **<https://MyVote.wi.gov>** on Monday to verify that their ballot is ready to be counted at the polls on November 3.
