# Sunset Village Neighborhood and Nearby Project Updates

## Blackhawk Ave at University Ave: Median Island and RRFB (Rectangular Rapid Flashing Beacon)

The completed project is a pedestrian diagonal crossing configuration with no left turns onto University Ave.



## Redevelopment at 3535-3553 University Avenue and 733-737 N. Meadow Lane

The project is a six-story mixed-use building with 4,268 sq. ft. of commercial space and 146 apartments, and driving access on N. Meadow Lane. Demolition was completed in December.

On December 19, 2025, Sunset Village resident Rich Kedzior emailed Alder Vidaver: "The City gave permits to the developer of the new apartment building on University Ave at Meadow Lane to close the sidewalks on both streets. I might understand the need to close the sidewalk on the south side of University Avenue if the structures were especially close to the sidewalk but only temporarily during demolition. However, I do not see the need to close the sidewalk on 150 feet of Meadow Lane at all. There is no sidewalk on the west side of Meadow Lane, only on the east. Pedestrians on Meadow are now forced to walk in the street; during winter (and more so at night) it is especially treacherous." Rich goes on to say, "I worked as a general contractor and property developer in Chicago for a few years. The City of Chicago would never give a sidewalk closure permit to demo buildings that weren't close to the sidewalk and never for the duration of construction; Chicago might require the sidewalk be moved to the street, but would never permit complete closure."

Alder Vidaver is looking into this with City traffic engineering and has yet to receive a response. Stay tuned.



## Midvale Blvd Resurfacing & Safety Improvement Project

Based upon neighborhood public input, Transportation Commission feedback and City staff analysis, City Traffic Engineering and Engineering staff are proposing to replace the resurfacing project with a pavement patching project in 2026, along with programming for a full reconstruction as soon as funding is available. The project would not change the layout of the street. It would add a painted line between the parking lane and the traffic lanes. The full reconstruct will allow for full utility replacement (sanitary, storm, water) as well as a new curb alignment, which should allow for both All Ages and Abilities protected bike facilities and parking pockets.

Staff recommend including the following safety items in the patching project. The final design will confirm the timeline and details for implementing these items. If needed, the Safe Streets Madison Program will launch a separate project in 2026 to improve pedestrian safety.

- Spot pavement patching in the worst areas
- Marked line between parking/travel lane to change the feel of the street
- Curb extensions into the street to manage speeding and improve pedestrian crossing
- Pedestrian activated push button flashing lights and signs (RRFBs) at Hillcrest & Heather Crest
- Enhanced painted crosswalks for better visibility

We will also evaluate bike routes parallel to Midvale for improvement. The future full reconstruction will be a new design project, including full public outreach.

# Sunset Village Neighborhood and Nearby Project Updates, cont'd

## Woodland Reserve Apartment Complex

J.D. McCormick plans to add additional density to the Woodland Reserve property between Bluff and Stevens Streets. The proposed project is to add an additional 62 dwelling units over (4) buildings to the existing Woodland apartment complex. The two larger buildings are three-story + loft level apartment buildings with underground parking and pitched roofs. The two smaller buildings are two-story carriage-house style buildings with independent unit entrances, individual garages and pitched roofs. The smaller buildings each include a ground-floor unit for accessibility requirements.

A major neighborhood concern is the preservation of the path along the east edge of the property, which connects Stevens and Bluff Streets. Current design restores the path between Stevens and the McKinley cul-de-sac, but replaces the McKinley to Bluff section with a sidewalk internal to the property. 

## Remembering the Abundant Life Christian School Shooting

As I write this article, we have just passed the one-year anniversary of the shooting at Abundant Life Christian School (ALCS). That anniversary comes on the heels of two additional high-profile shootings: on December 13, 2025, two Brown University students were killed and an additional nine people injured, and on December 14, 15 people were killed on Bondi Beach in Australia while celebrating Hannukah. My heart is heavy with these losses, and I, like many, feel powerless to stop any of this.

It's no secret the U.S. has the highest per capita number of guns as anywhere in the world. The second amendment to the U.S. Constitution has been interpreted to allow individual gun ownership under most circumstances, and the Wisconsin State Constitution states that "[t]he people have the right to keep and bear arms for security, defense, hunting, recreation or any other lawful purpose." St. Paul, Minnesota recently passed a resolution that—if their state repeals pre-emptions—would ban assault weapons, large-capacity magazines, and "ghost guns", and restrict firearms from parks, libraries, recreation centers, and city buildings. Seeing this, I asked if Madison could follow suit. Alas, our City Attorney concluded that due to the way our state constitution is written, there is no wiggle room, even for a resolution that wouldn't take effect until state laws change. Therefore, we're left only with the resolution the Madison City Council passed on the heels of the ALCS shooting, which urges the Wisconsin State Legislature to enact common sense gun control including, but not limited to, universal background checks and red flag laws.

As I read through the Wisconsin State Journal's in-depth coverage of the radicalization of the ALCS shooter, I was truly shocked. I cannot imagine people taking pleasure in watching real-life horrors. It may not be obvious, but at the local level, we do not have the authority to restrict such horrendous websites or chat rooms. The ALCS shooter's story is also an indicator of the importance of parents staying present and regularly overseeing their teens' online usage, as difficult as that may be. We also need additional resources for mental health support, because, let's face it, healthy minds don't seek out these horrible materials. As a community, we do have the opportunity to create engagement opportunities for our youth and families. I'm deeply proud of the way Madison supports our libraries, parks, schools, and community cultural events, as these are all ways to keep folks interested and involved in positive activities. Obviously, these weren't enough to engage the ALCS shooter, but they may help connect someone else who might otherwise fall down such a slippery slope.

As we remember this heinous event, my hope is parents, teachers, and community members can learn more about how to spot young people experiencing mental distress, and know how to ask for help. I also believe it's well past time to call on our state and federal representatives to find ways to regulate violent websites and chat rooms as unprotected speech, and do more to restrict access to firearms. It takes all of us to protect our community from these ills.
